The same obverse die was used for each piece, with the inscription within a 17 mm circle, unlike the genuine tokens. The reverse die of each piece has a ring of dots inside the raised rim. The genuine pieces do not have the ring of dots. "Wright Cin. O" is on the obverse of the counterfeits, while the genuine pieces have "Wright & Son Cin O."
